Information on the use of personal data/privacy policy:

With my signature I acknowledge that my personal data (first name, surname, in some cases first name and surname of the legal guardian(s), date of birth, address, postal code, city, telephone number, e-mail address, date of entry) will be processed electronically and manually within the club on a contractual basis (membership). The purposes of the processing are: sporting, organizational and professional administration and financial processing, membership administration, sending club and association information, information about events, the chosen division/sport or the exercise unit occupied. The association Space Quads is the controller of the processing activities set forth herein. The provision of my data is necessary for the fulfillment of the purpose of the association according to the statutes, if not provided, membership to the association is not possible. In case of resignation from the association, all data will be deleted at the latest within one year after resignation, provided that there are no arrears of payments on the part of the member, the data are not required for the assertion, exercise or defense of legal claims of the association and no longer storage of the data is required by law.
